# **Message From the President**

l begin this letter with an appeal to our membership. Please give generously to our PAC Levy Fund. I know it feels like we are in a good place with our community and we have faith in the tradition of levy passage in our district. However, stakes are too high to warrant anything less than our full engagement in the process. As you know, we cannot give to political campaigns as an organizational body due to our by-laws. However, we do have a PAC that can. Donating \$10, \$20, \$30 or more to the Levy Campaign goes a long way not only in supporting levy efforts, but also in letting the community know where we stand - alongside our students, advocating for the best education that we can provide. By this time last levy cycle, our members had already contributed over \$3,000 to the PAC levy fund. We have donated a bit more than a tenth of that thus far. Please send your check to Bill Scanlon at the High School written to "PAC of SHTA" with "Levy Fund" in the memo line.

Likewise, I encourage you to volunteer with the SHTA through our PAC for a levy phone call night. You are surrounded by good people from our community and the other bargaining units in the district to talk to other community members about supporting the levy. As someone who knows the importance of our budget to making programs in this district work, your voices are invaluable on the phone. Our Executive Board will be making phone calls. When Eileen Sweeney sends out the opportunity via email, I hope that you sign up and show up as well.

It's been a busy Spring thus far. I dealt with disciplinary and evaluation issues throughout the district. I met with Mrs. Robinson and Dr. Stokes concerning evaluations, transfers, building issues, and upcoming district initiatives. I met with Vice President Matt Zucca, Secretary Darlene Garrison, and Treasurer Bill Scanlon to discuss Association Issues. I talked to Ouimet Smith, Registrar, concerning future ALICE security training. I attended the AdvancED accreditation presentation at the High School. I conversed with Dr. Hutchings about upcoming negotiations and district concerns. Finally, I conferred with Erin Herbruck and Lisa Scott about eTPES notifications, indicating only that teachers names have been entered into the online system, and extending the specialist evaluation deadline to May 30th.

On a final note, I would like to respond to questions about teacher retirement and the SHTA's role. First of all, we do not have a retirement committee because the retirement process is so individualized that we don't believe you should consult with anyone but your own STRS advisor. Secondly, our district's protocol for Severance Pay is in the contract. Feel free to contact your representative council members with questions relating to contractual issues or peruse the contract yourself at <u>www.shtaweb.org</u>. However, reserve those vital retirement questions for your STRS

advisor. These decisions are too important to make with anything less than first hand information.

It continues to be a pleasure to serve as President of the Shaker Heights Teachers' Association. We are a group of consummate professionals who provide great service to our students, our schools, our peers, and our profession. I encourage you to make a public affirmation of our role by contributing to the PAC Levy Fund. I will be doing the same. # **TREASURER'S REPORT**

We need to support the upcoming levy, for the sake of the children we teach. Despite how happy or unhappy you are with the millage chosen by our Board of Education, this levy is essential to the continued high level of service our students deserve. In that effort, I have been collecting checks and cash and using the PAC of SHTA to send that money as a lump sum to the <u>Committee for the Shaker Schools</u>. So far we have sent \$345 to the levy fund, with another \$90 collected to send along. We can do better. # **EXECUTIVE BOARD REPORTS**

# PROFESSIONAL RIGHTS AND RESPONSIBILITIESREPORT

"Personal days are personal," said retired PR&R chair Gary Raymont. This is still true. You do not have to ask for approval for a personal day, unless it is before or after a holiday. You should enter it into AESOP yourself. If you want to have a personal day approved before or after a holiday, you should contact me first. If you receive a request with a DENIED stamped on it, your check will be adjusted based on an absence without pay. Also, check in AESOP to make sure you have personal days left. Teachers get 3 personal days per school year. If you don't use them, they are added to your sick days at the beginning of the next school year.

"You don't have to complete FMLA paperwork if you are using sick days. Throw it away if they send it to you," said retired PR&R chair Gary Raymont. This is not true anymore, and has not been true for three years. Whenever you are on an extended sick leave (maternity leave, surgery, illness, etc.), the school district has a legal obligation to send you a federal form related to the Family and Medical Leave Act (1993). You have a legal obligation to complete the form with help from your doctor. Completing the form is in your best interest. It takes the place of a note from a doctor, and it includes more detailed information about your leave and when you may return to work. The form gives you the right to use sick days during your absence. Make sure you check the box that states you will be using sick days during your leave, or attach a note about your intentions. If you don't have many sick days, you can take an unpaid leave and keep all your insurance benefits for up to 12 weeks per year. This type of leave (with or without sick days) may also be used to care for a sick family member. It is a benefit labor organizations fought for in the early 1990's. Thank you President Clinton for signing it.

"The administration is not your friend," said retired PR&R chair Gary Raymont. This is still true, especially when applied to teacher evaluations. I wonder what Gary thinks about OTES. Everyone should review the OTES rubric, which you can find on the shaker.org website under Teacher Evaluation, before you have your summative evaluation conference with your administrator. If you have any concerns that the rating assigned to you and the evidence presented does not match the guidelines in the rubric, do not sign your evaluation. Also, you have the right to bring additional evidence to your administrator and request another meeting after they have had time to review the evidence. It is their responsibility to review all the evidence about your teaching that you provide. The summative rating is designed to be holistic, and should consider all five areas on the rubric. If you think your evaluation is not being done correctly, speak to your building representative immediately. I have formed a Grievance Committee, and we will be studying evaluation violations on a case by case basis before deciding whether or not to file grievances. All members of the Grievance Committee are either SHTA officers or on the Executive Board.

John Morris appointed me to a committee, which is overseeing the interview process for the Middle School Principal and the Assistant Superintendent/Business Manager. Erin Herbruck asked me to serve on a committee that will help plan Convocation in August. I met with the Negotiations Committee to help plan a member survey for May related to next fall's negotiations. I am also currently working on a worker's compensation issue and two adoption leaves of absence.

# **POLICY COMMITTEE**

As our school year reaches the home stretch, we must begin planning ahead for next year. As a member of Our Association, perhaps you may consider seeking more responsibility within our organization. One way to participate is to become a building representative. This is our monthly constitutional concern - BY-LAW II, Section C: Election of Building Representatives

1. Before the end of the current school year and not earlier than the 2nd of May, each building shall elect its representative(s) and an alternate to serve during the next school year. The current Building Representatives shall notify the members within their building of the date and location of the election no later than one(1) week prior to the vote. All ballots will be collected and sent to the Elections Chair for tabulation. The results of the building election shall be published by the Elections Chair, who will notify the members of each respective building of the outcome of the election. In the case of more than one representative, one shall be designated the Building Chair. The Elections Chair shall report the results of the election to the Secretary before the close of the school year.

In an unrelated side note, I recently experienced problems renewing my teaching license through the ODE's new online system. I discovered a solution which may help other members who get stuck during the online application process, particularly with the required district LPDC signature. I achieved success by typing in 'Shaker Heights LPDC', but I believe our districts LPDC IRN will work as well: 014771.

# **LEGISLATIVE COMMITTEE**

We need you to take a stand. The Ohio House of Representatives has made radical changes to Senate Bill 229. As you may know, Senate Bill 229 is a bi-partisan proposal to positively modify the current Teacher Evaluation Law. The Ohio Federation of Teachers, the Ohio Education Association, and most unaffiliated associations back the Senate version of Bill 229 as a step in the right direction for teacher evaluations. The Ohio House of Representatives has gutted the Bill and proposed a new version that will negatively impact your collective bargaining rights. The differences in the two versions of the bill are illustrated below:



The bottom line is state legislators are trying to make teacher evaluations worse. Act now. Tell your state rep to pass the Senate version of SB 229 without changes. I have shared a letter with you on your email outlining concerns and urges their support of the Senate version of Bill 229. # "RIGHT TO WORK IS COMING"

It may seem alarmist to begin in such a dire way, but we have only to look to our brethren in Wisconsin for the results that such legislation has on our profession. Teachers' salaries in Mequon-Thiensville School District near Milwaukee were frozen for two years. Employee contributions to health care rose and a merit pay system was implemented. The retirement age for some districts was raised. In Oneida County, Wisconsin, county supervisors rid contracts of "just cause" language, allowing for the immediate firing of employees, making workers fear speaking out about anything. The state of Wisconsin has increased employee contribution to their pension by 6% and their health care by as much as 12%, leading to many state workers having a 12% pay cut on top of wage freezes. Some past-union members are now receiving food stamps because of the loss of income. In December of 2013, 400 school district unions asked for recertification. Eighty

were decertified because they failed to get the needed majority. Worst of all is the morale of those still in the unions and those that were in the unions. The hundreds of thousands that marched on the state capitol protesting Governor Walker's policies feel destroyed, hanging on to their former lives as best they can (Greenhouse).
