Message From the President

It's hard to believe that the next time this newsletter comes out we will have elected a new President of the United States. Although we cannot endorse political candidates as an Association due to Our Constitution and By-Laws, it's impossible to emphasize how important it is to vote this election. The future of our country is at stake. The next President could appoint four Supreme Court justices. I strongly encourage each and every one of our members to exercise their right to vote. This may end up being one of the most important elections of our lifetime.

Closer to home, we have seen the fallout of the Ohio State Report cards and our district response, Measuring What Matters. At Monday night's Representative Council Meeting, Dr. Marla Robinson shared her and Dr. Gregory Hutchings thoughts on the report card results and the research that finds that test scores are directly related to the economic status of a district's students. Highlights from a report that Dr. Hutchings provided, from an analysis from Warren Local Schools Superintendent Kyle Newton, included the following findings:

- Not one district with more than 18% poverty received an "A" on Indicators Met. 524 districts have more than 18% poverty; that is 83% of schools in Ohio and none of them received an "A" on any indicator.
- Only two districts received an "A" on Performance Index Score. One has 0% poverty and the other has 9% poverty. One is ranked in the top 16% while the other is in the top 10% for property value.
- None of the 100 poorest schools, by property valuation, received above a "D" or an "F" in Indicators Met.

Similarly, a Fordham Institute analysis of the State Report Card, found the following:

- Because of changes in benchmarks, fewer students in Ohio are deemed "proficient" on state exams than in previous years. In 2015-16, roughly 55 to 65 percent of Ohio pupils met the proficiency bar in the core subjects.
- In turn, school ratings across that state have declined. In urban areas, public schools receive almost universally low ratings on proficiency based metrics: On the state's performance index—a key gauge of student achievement—94 percent of urban schools received D or F ratings in 2015-16.

In a nutshell, the higher the poverty levels in a school district, the lower the letter grade on the State Report Cards. This fact alone invalidates these scores and emphasizes that schools as economically diverse as our own are punished by a reductive report card system. Our own high school English teacher and Member Chris Cotton tackles the issue in the editorial at the end of the newsletter. **It is a must read!**

Even closer to home is the issue of the District Master Plan and the upcoming May Bond Issue that will be voted on by Shaker residents to provide 55 million dollars for a new Middle School and improvements to buildings throughout the district. The SHTA enthusiastically supports this bond issue and the necessary improvements it makes to our buildings, including the replacement of one of the most difficult to maintain and utilize buildings, the Middle School. We have not had a bond issue in Shaker in over 10 years. We are overdue for necessary improvements to our physical plant for the wellbeing of our students, our teachers, our schools district, and our community.

Otherwise, it has been a typically busy month as SHTA President. I attended the Instructional and Administrative Council Meeting, where we were able to agree upon a two-hour window on the November 22nd Professional Day for members to complete Public School Works online modules. I addressed a fan issue at Woodbury, with the help of Keith Wagner and Darlene Bushley. I addressed Diploma Programme concerns at the High School. I addressed 504 coverage and an evaluation issue at the MS along with Principal David Glasner and Addie Tobey, evaluation committee member. I addressed personnel concerns with Darlene Bushley. I continue to discuss testing issues with Dale Whittington. I am working on a continuing contract issue among out-of-state teachers with Matt Zucca and Susannah Muskovitz. I attended the Master Planning meeting. I updated Our Facebook page, along with Andrew Glasier, and The Cuyahoga County Educator Summit page. I continue my weekly conversations with Dr. Hutchings. I discussed 504 concerns with Tim Gesing and Sara Cole who provided clarification, which was shared with Woodbury administration. I helped resolve a contract issue for Support Teacher concerning lunch period with the help of Onaway Principal Eric Forman and Building Representative Paula Klausner. Finally, I interviewed with The Shakerite.

As fall begins, please do your best to get out and enjoy this beautiful season in Ohio. On November 8th, make sure you vote. Once again, we will be facing a completely different political world based on the outcome of this election. Exercise your fundamental right as an American citizen and vote! 
TREASURER'S REPORT

LEGISLATIVE REPORT

The Ohio Federation of Teachers (OFT) has an invaluable resource to monitor laws enacted by State Representatives and Senators that directly impact the important work we do to advocate for our students. To keep members informed about pending legislation that will change how we do our work to meet the varied needs of children, OFT has created legislative reports that track the current status of bills as they move through the Statehouse.

Senator Joe Schiavoni (D-Boardman) released a statement after the Ohio Department of Education (ODE) found in their [final review](#) that the Electronic Classroom Of Tomorrow (ECOT) exaggerated student attendance by nearly 60%. This finding could potentially mean ECOT owes upwards of \$60 million in funding back to the state. He has requested the State Board of Education and State Superintendent of Public Education explore hiring an independent auditor to examine the records of ECOT.

Finally, early voting has begun. Guides for early voting by mail and in person can be found on your Board of Elections (see attached link for Cuyahoga County: <http://www.boe.cuyahogacounty.us/>). It is important to keep abreast of your voting registration and news of the elections. It is interesting to know that the American Federation of Teachers, the National Education Association and the Cleveland Teachers Union have all endorsed Hillary Clinton whereas the Cleveland Police Patrolmen's Association has endorsed Donald Trump. EVALUATION COMMITTEE

Evaluation conferences and observations have begun across the district. All evaluation information and forms are available on shaker.org for you to access. Some important reminders about the evaluation process are as follows:

- All pre and post observation conferences and observations must be scheduled *at mutually agreed upon dates and times*.
- Professional Growth Plans should be written by individual teachers and shared with evaluators.

Evaluators should not change goals on these plans or dictate the content of goals, but rather support teachers in reaching their own goals. Professional Growth Plans should have been completed and uploaded by September 30.

- Teachers are encouraged to submit additional evidence to their evaluators to be included in their evaluations. Teachers should upload these pieces of evidence directly into eTPES. Be sure to tag each piece with a title and date.
- The evaluation process should always be conducted with the goal of professional learning and development, rather than in any kind of punitive or “gotcha” style.
- All teachers will have a minimum of two Informal Observations, formerly known as walkthroughs, one each semester.
- eTPES will continue to be used to house evaluation forms. Remember, there are items on eTPES that should be “skipped”, as they are not part of our current evaluation program. They include the Pre-Conference (these questions are discussed during conferences) and the Teacher Professional Project. The Improvement Plan item is only used for those on state or district mandated improvement plan, otherwise it can also be skipped. Please forward any eTPES questions or concerns to your SHTA representative or a teacher on the Evaluation Committee.
- The “Evidence Summary Form” is now called the “Performance Rubric” but will function in the same way as before.

Please be sure to connect with me, or any member of the evaluation committee, with any questions or concerns you may have.


PAST PRESIDENT’S REPORT

- Thank you for helping the Intervention Specialist and their lunch period. Specialist no longer has to walk from building to building eating their lunch.
- Issues with fire regulation codes.
- Health Inspector said that the Art Room needed an eye wash unit.

Woodbury, Angela Goodrum

- Teachers were told to treat fabric items in the classroom and they would not have to be removed through an email. They were told that they still had to be removed. Will they be reimbursed for purchased items?
- Teachers are asking the Woodbury Technology person for help with their concerns. The technology person never gets back to them, should they go directly to the Help Desk instead?
- When the Woodbury clock/bell tower was refurbished this summer, some additional land/hardscaping work was done in front of the Woodbury steps. It noticed the architectural stones that surrounded the landscaping bed were removed and not replaced. Also, the brick used to pave the area in front of the steps is concrete pavers, not clay bricks. These clay pavers are cheap and an inferior product to clay pavers. Answers please...

Middle School, Kathy Manning

- An inaccurate statement regarding counselors posted in the recent SHTA newsletter under Middle School Concerns needs to be clarified: School Counselors get paid units for attending the Summer Leadership Institute and per diem rate for the scheduling work that must take place over the summer like every other counselor in the district.
 - This statement is a correction to what was reported in the last SHTA newsletter. SMS counselors have always been paid the same units as other teachers who attended the Summer Leadership Institute.
- Testing Challenges: On-going and frustrating. We have met with administration 5 times to resolve these issues. Our principal has assured us that they will be resolved before the next testing date. Stay tuned.
- Planning Period Disappearance: Final resolution to the multiple scheduling of 504, IEP and parent meetings being scheduled during teacher's planning time. Per Human Resources, Our Association and administrators it has been agreed that every effort will be made to schedule these meetings during Raider Time (3:00-3:45). If they cannot be scheduled during this time, teachers are advised to attend and then submit a pay slip to secretary. In the case of 504 and IEP meetings, it is mandatory that 1 member of the regular education team be present.
- Can some type of symbol (like eyeglasses for IEP) be created in Progress Book for indication of a 504?
- Noise pollution: Repeated requests were made over the years to not mow under classroom windows during the school day. Finally reached an agreement with our awesome maintenance crew.
- Reviewing excessive paperwork (daily lesson plans). Are we the only building?
- PGP Goals: Many members receiving their PGP goals back and being directed to include a MAP goal. PGP goals are specific to the individual and should be connected to previous evaluations, and their choice. Still under discussion.
- Should building psychologists be evaluated by building administrators or central office/qualified to evaluate? (currently building admin).
- Linda Roth has resigned as building rep. Do we need to facilitate another election?

High School, James Schmidt

- Faculty and administration from other buildings as well as at the High School are allowing their high school children to drive a car with a faculty permit and park it in the faculty parking lot as well as on the street in the area reserved for faculty permit holders. **Please ask your members and administrators to stop this practice, as we are very short on parking spaces. Mr. Kuehnle has said that in the near future, students will be told to move their car on the first offense, and after that, we will tow these cars. The High School parking lots and the designated permit parking only areas around the Oval are for faculty, staff and visitors only.**
- I have been following up with Mr. Kuehnle regarding our need for new paraprofessional staff as well as intervention Lab staff. There are 276 students that require small group testing per their IEPs and 25 that get 1 on 1 testing. There is a concern that these students are not receiving these accommodations and that we are out of compliance. Mr. Kuehnle has met several times with Dr. Breeden and has been asked to produce evidence and data to justify these needs, which he believes that he has done. We are waiting to hear back from Central Administration regarding this hiring.
- With the switch to being a Google District, some teachers have expressed concerns that there are students and families that lack access to computer resources, due to lack of hardware (computers) or internet access or both.

- We resolved an issue regarding the time at which students meet with Mr. Kuehnle for his Principal's Advisory Committee. They will be meeting on Tuesday mornings and not miss any further class time.
- Several teachers expressed a great deal of concern about the nature of some questions that students on the Superintendent's Advisory Committee were being asked, namely which teachers allow you to use headphones in class, which teachers allow you to put your head down in class, etc. Students expressed to a teacher that this line of questioning made them feel extremely uncomfortable.
- The new process for Professional Learning reimbursement is tied to completing the feedback in My Learning Plan. I have been told that not filling this out promptly may delay the reimbursement of personal funds that teachers spent to better their craft and we find this troubling.

Crunched by the Numbers

There are three kinds of lies: lies, damn lies, and data.

— Mark Twain (actually, Twain said “statistics,” not “data,” but it’s close enough)

The Ohio Department of Education has given us an F in “Gap Closing” (which is pretty much what my wife gave me after I attempted to insulate the house before a particularly cold and drafty winter). The sweaty toilers of the ODE engine room shoveled our numbers into the great cruncher. The digits tumbled into the spinning teeth of its mighty algorithms. It chewed, it cogitated, it spat out a judgment. Shaker: F.

First of all, I’d like to point out that 86 percent of Ohio’s 608 school districts flunked this category. If we teachers gave a test that 86 percent of our students failed, we would assume there was something wrong with the test. But this percentage is a political, not educational decision.

In any case, the data makes us look bad. Or does it? It all depends on how you chew it. For example, our African-American and Economically Disadvantaged (ED) kids, the ones on the lower tier of our gap, scored better than the white kids in Cleveland and in several other Ohio districts. Where’s your gap now, ODE? Our ED kids performed vastly better than the same demographic groups—regardless of race—around the state and around the country. Might that be a sign of something we’re doing right?

The problem is that no matter how well the lower tier of our gap performs, it’s being compared to a group whose numbers are severely distorted by our very top-performing kids. The district rightly boasts about our graduates who are Presidential Scholars, National Merit Semi-Finalists, Ivy Leaguers, etc. etc. But the exceptional number of these exceptional students is proof *not* that we’re great educators, but that we have a freakish concentration of freakishly smart kids. According to “Measuring What Matters,” we are the 17th most educated community in the nation. That puts us squarely in freak territory: the top tenth of the top one percent of the 40,000 American cities and towns. We have many kids who come from families in which not only both parents have advanced degrees, but all four grandparents went to college. Most of these kids are going to be good students. Many will be superstars. And when you throw high income into the mix, the superstars are issued capes and wrist web-shooters and bullet-deflecting bracelets.

We do a tremendous disservice to our students—in any disaggregated group—when we compare them to these outliers. If we want to construe any meaningful lessons from the data, we ought to toss out these off-the-chart scores before we do any calculations.

We often hear something like this: “We can close the achievement gap, because we are Shaker.” I would put it the other way around: We *can’t* close the achievement gap, because we are Shaker—a community with extreme inequalities in income and family educational background. Certainly we should work on narrowing the gap. Certainly we *must* bust our butts every day to narrow the gap. But if we think we can erase it, we’re chasing unicorns.

The gap was not caused by schools; schools can’t make it go away. For one thing, the kids arrive—whether first grade, kindergarten or pre-school—with an achievement gap already firmly in place, already gaping wide. We can create programs for the disadvantaged kids, we can work relentlessly on pulling them upward, but the gap may not budge. This is because the advantages don’t stop pouring in for the advantaged

kids: nightly book readings, educational toys, museum memberships, tutors, psychologists, painting lessons, pottery classes, iPads, cameras, chemistry sets, horses, hockey teams, telescopes, cello camps, complete sets of Harry Potter. The parents not only understand the homework, they have the time to help with it—and also with the dioramas, book-binding, mousetrap-powered cars, baking soda volcanoes. As they get older, the disadvantaged kids get more and more opportunities in Shaker. I'm proud of all the programs that our district sponsors to help these kids. The energy and money we put into these programs are exemplary. But advantaged kids also get wonderful opportunities in school. And on the weekend they go to Shakespeare plays; when there's a day off they shadow their parents at the Cleveland Clinic; for spring break they go scuba diving in Costa Rica; over the summer they tour the museums of Europe.

Our achievement gap not only doesn't close over the 12 years of schooling, it grows slightly wider. And here we make another serious mistake when we interpret the data. We assume that, if we were a truly equitable district, the data would show it by having a gap that decreased, or at worst, held steady. But this assumes that learning is a straight, upward-slanting line, a steady accumulation of knowledge and skills. This is a fundamental misunderstanding of how the brain educates itself: not by inputting information, but by loading software. Growth is exponential. The more you learn, the better you get at learning. You learn faster; you retain more; your brain makes new connections and quantum leaps. Our achievement gap widens only slightly over the school years in Shaker, and this is a genuine achievement.

It appears that our district has begun to supplant the term “achievement gap” with “opportunity gap.” I haven't heard the rationale for this decision, but it seems to me that we are reaching for whips with which to flagellate ourselves. “Opportunity gap” implies that the fault lies squarely with us: for surely we control what opportunities we give our students. But it is *our society* that has an opportunity gap. And this colossal injustice manifests itself in schools as an achievement gap.

What the data shows us is that, in our little community, we're doing a damn good job at battling an epic problem—a problem as wide as the nation and as deep as the most hidden and poorly understood mechanisms of the human mind. A problem as old as the Nina, the Pinta and the Santa Maria. Before that, the data is kinda murky.

I am certainly not advocating complacency. I'm not saying we should stop trying to close the gap. We should strive with every fiber of our teaching souls to reach and engage and inspire the kids on the lower tier of our gap. The obstacles in front of them are a monstrous injustice.

But when we hold ourselves to the impossible benchmarks of the ODE, when we hold up illusions as our standards, we not only set ourselves up for failure and recriminations, but we do a real disservice to the kids we want to help. For some of these kids are truly brilliant, some of them are pushing themselves to the limit, day in and day out, some of them are walking miracles. And are we telling them that no matter how hard they work, no matter how high they achieve, it's not enough?

The failing state report card has led to a lot of hand-wringing in the district, and some urgent communication to parents. But—can I tell you a secret? This is one hell of a good school system. We know it; most of the community knows it. Personally, I'm proud to be a Shaker teacher. I'm humbled by the work of my colleagues. The only message we need to send regarding the news from Columbus is to the ODE itself: take your report card and shove it where the data don't shine.

There. I feel better already. And now I need to get back to work.
