Message From the President

In the last few newsletters, I have emphasized our need to be aware of national and state educational issues. Now we need to focus on the local.

On May 2nd, Shaker voters will decide on a 3.75 mil capital levy that will provide a much needed 30 million dollars to improve and maintain our schools. I emailed a letter to our membership, from myself and PTO Co-President and Committee for Shaker Schools Chairperson Heather Weingart, asking that we donate to the capital levy campaign and volunteer to place yard signs on our Shaker properties. In an effort to make the donation easier and more impactful, I would like to encourage you to send a donation to SHTA Treasurer and PAC Co-treasurer Bill Scanlon at the High School. Please send a check to the Shaker Heights Teachers' Association with "PAC Levy" in the memo line. Every contribution of any size helps. Then we can send a check to the Capital Levy Campaign collectively from the SHTA PAC. Also, make sure that you endorse the capital levy through the Capital Levy Campaign webpage <https://sites.google.com/site/shakerheightslevy/donate>. With roof leaks at the Middle School, ADA compliance issues in many buildings, routine maintenance throughout the district, and modern and flexible furniture for all of our classrooms, the necessity and benefits of this capital levy are obvious. It's been thirteen years since our 2004 capital levy. The time is now for this crucial investment and your contribution can help.

League of Women Voters to discuss the Capital Levy Issue.

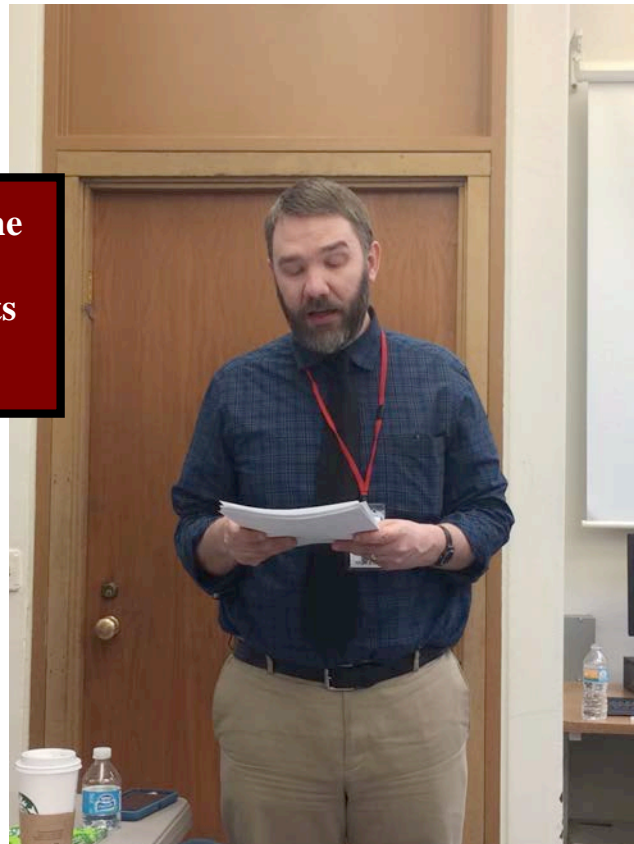

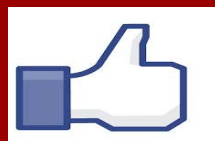

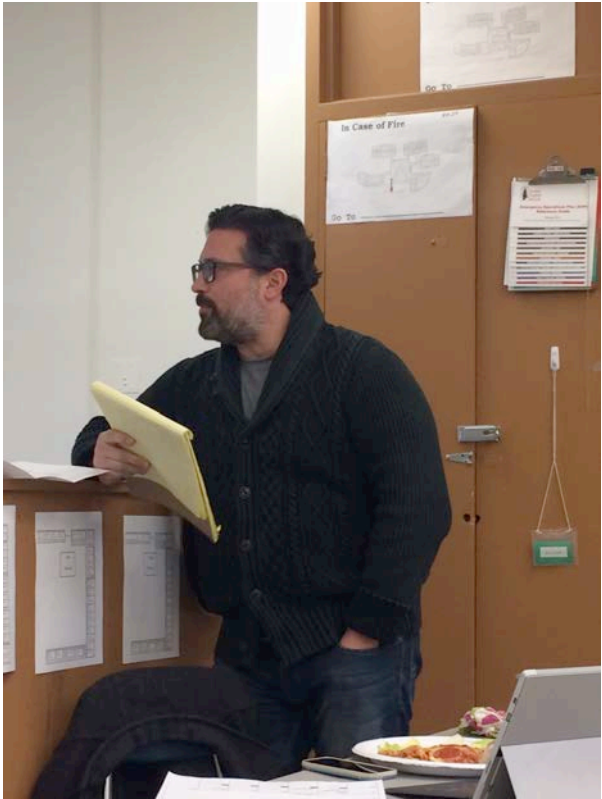

One year ago in my March 2016 newsletter report I wrote, "We are in the midst of a crazy presidential campaign year. It is ridiculous and comical." 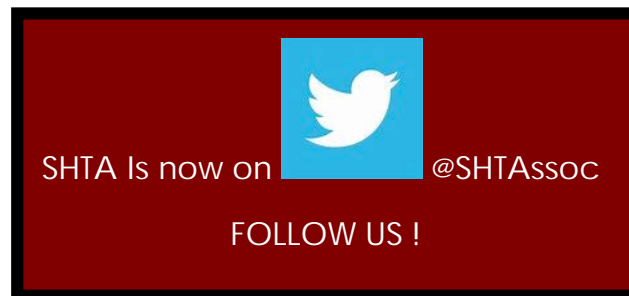

EXECUTIVE BOARD REPORTS

PROFESSIONAL RIGHTS AND RESPONSIBILITIES REPORT

In the last month, I helped the representatives at the Middle School organize a building meeting. Twenty members discussed OTES, standardized testing, and the physical condition of the building. John Morris attended and answered questions. We also used this meeting as an opportunity to recruit future leaders.

I filed a grievance for several Middle School members regarding the violation of Article XVII:

ARTICLE XVII - PROGRAM, CURRICULUM AND ASSESSMENTS

17.01 Teachers are expected to participate with department chairs, supervisors, and principals in decision making regarding curriculum development, implementation of program, evaluation of program, textbook selection and curriculum revision. Careful consideration shall be given for balance in relation to grade levels, subject areas, types of students being served, special training and interest in the particular field.

17.02 Taking into consideration the number of state-required assessments, every effort will be made to ensure that district-wide testing will focus on multi-purpose assessments that inform instruction and, whenever possible, minimize the impact on instructional time.

The grievance focuses on 17.02 and argues that the current testing schedule at the Middle School does not make “every effort to minimize the impact on instructional time”. The grievants also believe 17.01 is being violated because there is either no teacher input into the testing schedule or any teacher input that is happening is not being communicated to the members.

The members decided to file a step 2 grievance because they believe decisions about the testing schedule are made at the administration building. Building representatives have met with building principal Mr. Glasner about the testing schedule, and he has made some beneficial changes. However, the grievants believe more changes are needed to comply with our collective bargaining agreement.

I also assisted members with questions about maternity leave and sick days. The only way to collect severance pay for unused sick days is to retire from the Shaker Heights City School District. If you change employers before retirement, you lose the right to collect severance pay.

The supplemental committee met again on March 1 to review current contracts for clubs and activities. We are almost finished, and should make final recommendations to the Board in April.

EVALUATION COMMITTEE

The Evaluation Committee met during the first week of March. Prior to the meeting, Andrew and I worked with Director of Human Resources Darlene Bushley and educational consultant Fran Prolman to create a Skillful Teacher crosswalk document. The document aligns elements of the Performance Rubric with sections of *The Skillful Teacher* book. This document will be finalized and shared by next school year.

During the meeting, I shared concerns some of you have shared regarding alignment of the rubric to your specific position, including single subject teachers, support teachers, and others. The committee is suggesting that concerned groups or individuals communicate specifically which parts of the rubric do not apply to your position so that we may further review this concern.

We also are working to review, edit, and revise the Evaluation Packet so that it clearly reflects protocols and expectations. There continues to be concerns about protocols being followed, which was also discussed. Due to the high number of teachers in a Formal Evaluation year, this year's evaluation load is higher than the past two years, which accounts for some of the issues. This will be a recurring issue if the mandates for evaluation remain the same.

Peer Evaluation continues to be a successful program that supports teachers in collaborative professional learning. The Evaluation Committee is looking to increase the number of participants next year with the support of both central and building administrators. Peer Evaluation intent forms will be distributed in early April.

Please consider joining this program! Individuals will not be required to find their own partner in order to apply. OTES Training will need to be completed by the end of September 2017. LEGISLATIVE COMMITTEE

We Are Ohio, statewide unions and Senator Sherrod Brown are leading the fight against so-called "Right to Work" legislation in Ohio. So-called "Right to Work" designation means private unions can't force workers to join or pay dues. In the Senate Bill 5 fight over five years ago, *Organizing for America*, Obama's political organization provided the structure for unions and political groups to act in concert against so-called "Right to Work". Now, there is a void and a reorganizing effort since *Organizing for America* is not spearheading this effort. Local unions and individual members must step up and get involved in the opposition to so-called "Right to Work" legislation. Every member must talk to their neighbor and friends and inform them of the devastating consequences of so-called "Right to Work" as well as contact their representatives on a consistent basis to

express their opposition.

In response to the Governor Kasich's state budget (House Bill 49) proposal to require that, as part of the teacher license renewal, all teachers must complete on site work experience with a local business or chamber of commerce. Reps. Brigid Kelly (D-Cincinnati) and Kent Smith (D-Euclid) are calling their legislation the GET REALS Act, with requirements that Kasich spend 40 hours -- that is, five eight-hour days -- in public schools with teachers, janitors or food service workers.

Implied in HB 49 is the sick belief that the work of a teacher is not truly "real" work. This is all just more ignorance, arrogance and condescension.

The newest strategy in the effort to pass so-called "Right to Work" legislation in Ohio is to pass these law on the local level. West Chester, a township outside of Cincinnati attempted to propose to pass this law after a recent federal appeals court opinion opened up so-called "Right to Work" status to cities and limited home rule townships. Previously only states had the ability to make that designation. Then unions asked the federal court to reconsider the opinion on the matter and hold a hearing with a complete panel of judges. This process may take six weeks or it may take two years. At a township meeting about the issue, the building was bursting at the seams with hundreds of people packing the meeting room, lining the walls and crowded into the lobby area. The developments in this court case have held up the progression of the law, at least for the time being.

Congressman Steve King R-IA proposed House Bill 610 on January 23, 2017. This bill proposes to distribute federal funds for elementary and secondary education in the form of vouchers for eligible students and to repeal a certain rule relating to nutrition standards in schools. It provides grants and fiscal allotments to enable qualifying states to carry out an education voucher program. This is the beginning of the expansion of the voucher system and the defunding and destabilization of the American public school system.

We must take the responsibility to act to fight. The Political Action Committee needs members to step up and join. The PAC will meet only when necessary and will work on advocating positions on policies impacting education and our students. Alongside Mike Sears and Andrew Glasier, I have worked on the supplemental committee negotiations. The committee reports the negotiations are going well and hopefully near an end. A final proposal should be forthcoming and presented to President Morris and Superintendent Hutchings by month's end.

WE ARE NOT A BUSINESS!

First thought: how much are we spending on this ridiculous system? Looking at the new emoji-decorated kiosks, I wonder which box on the Strategic Plan we're trying to check off now. The very idea of these rating boxes is absurd, but far beyond being a waste of money and energy; they're also deeply demoralizing and downright dangerous.

The idea that any kind of valid data can be collected this way is laughable. When I showed him the "Smiley Terminal," my husband mentioned that he'd seen them before – in an airport bathroom. That's all well and good – but airport bathrooms aren't dealing with the well-being and development of children. The most damage that could be done there is some toilets being cleaned too infrequently.

Easy as it is to brush off the kiosks as silly, it's the surveys that go with them that are truly insidious. A little plastic holder invites button-pushers to take a card, leading them to a "Customer Satisfaction Survey." Let's leave aside for a moment the philosophy behind this idea, and consider just data-gathering attempted here. The survey is anonymous, but it asks for the name of the employee you interacted with, meaning anonymous people can call out anyone they want. Security guard writes you up for wearing your hat? Survey. Teacher refuses to change your child's grade? Survey. The data gathered here will be no more valid than that on ratemyteacher.com. This invalid data is then sent to HR. What exactly do they plan to do with this information? Will anonymous reports make their way into personnel files? It makes me wonder what our contract says about this new evaluation "system."

Much more damaging is the philosophy that led to the development of the survey in the first place. The corporate-reform agenda has made it to our front office.

We are not a business. We do not have customers. Students are not products. They are children, and we are trying to guide them to being ethical, responsible, informed adults. That process is messy, and it often leaves people unhappy. Our job is to do what is in the best interest of students, even if they (or their parents) don't like it.

The idea that we should be doing whatever we can to please our "customers" erodes the integrity of our profession. Teachers, administrators, security guards and every other adult in this building, have to make difficult decisions every day. We should not hear a voice in the back of our heads asking, "If I do this, will they go online and say bad things about me?" The language of corporate culture has no business in schools.

I am not saying we should not seek feedback, or that open and clear communication and community involvement are not important. Indeed, I give a survey at the end of the year to my students and parents asking for feedback on my teaching and the course. I don't always like what I see, but I value the results and have adjusted my practice in response. This is meaningful information, and I spend time calibrating the questions to measure what I really want to know. I get no sense that such thought went into the administration's survey, nor do I trust that the results will be used well.

We spend a lot of time checking boxes around here. Have we stopped to think of whether those are boxes we should be aiming for?

EDUCATION AS A BUSINESS?

The very silly “Happy or Not” kiosks placed in school offices show how, more and more, our central administration thinks of education as a business. Educators are seen as “service providers,” and students and parents are “customers.” This paradigm now dominates American thinking about education. Our own governor has taken it to absurd heights, with his proposal to require job-shadowing “externships” for teachers. We are dismayed to see our district rushing headlong down this same path.

We teachers wish to express our great disappointment in this development, and our firm belief that education, at its beating heart, is *not* a business, and that thinking of it as such does great harm to this district that we love.

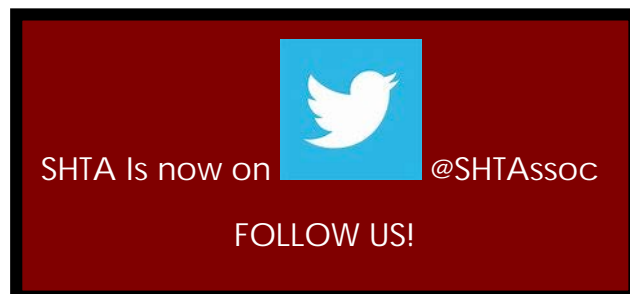
A business is a private entity created for private profit. A school is a public entity created for the common good. From these fundamentally different origins, fundamentally different institutions arise. Both are necessary for a healthy democratic society. Each one depends on the other. But neither will prosper by pretending to be the other.

Imagine for a moment that we made a little switch in the IB terminology. Can you picture a classroom poster displaying the “Customer Profile”? Immediately we can see how self-limiting this thinking is. We see the wisdom of IB in choosing a word that suggests active strength: “Learner.” Indeed, the IB program would call this paradigm a “Way of Knowing.” Like all ways of knowing, it offers insights, but also has blind spots. And when we decide to “know” our world in this blinkered, commercial way, we diminish ourselves.

First of all, customers are passive recipients of services. The providers do all the work and have all the responsibility. If a customer finds that a product is defective, then the culprit is always the provider. Education becomes, in the words of the poet William Butler Yeats, “the filling of a pail,” instead of “the lighting of a fire.” Parents-as-consumers also are passive recipients. They are released from responsibility for their children’s education. We grew up hearing from our parents and teachers the empowering motto: “You get out what you put in.” Now we have the victim’s mantra: “You get out what *they* put in.”

But mostly, this way of thinking undermines the central relationship of the educational process: student and teacher. We teachers do not see ourselves as providers and our students as customers. As parents, we certainly don’t allow our children to approach their own education with this passive-aggressive mindset. Rather, we see all of us as embarked on a grand cooperative venture—a process requiring commitment, struggle, integrity, and work, work, work from all sides.
