# Message From the President

One of my favorites responsibilities as SHTA President is giving out Our Service Awards. The SHTA Service and Lifetime Service Awards represent past and present members' commitment to Our Association and its membership. It is with great pleasure that I present Our Service Award to Mike Sears and Our Lifetime Service Award to Tom Patrick.

Service Award Winner Mike Sears is Our Professional Rights and Responsibilities Chair and a seventh-grade Social Studies teacher at the Middle School. Mike began teaching in Shaker in 1999 and this is his 18th year in the district. Mike was an SHTA building representative alternate, beginning in 2005-06 when Erin Herbruck (former head building representative) recruited him. Mike then served as head building representative from 2006-2009. This is his 7th year as PR&R Chair. His first year in the position was 2010-11. Mike was Legal Aid Chair during 2009-10, while he shadowed former PR&R Chair Gary Raymont. Mike has also served on two negotiations teams.

Mike's proudest accomplishments are the work he's done with negotiations, such as the stipends during tight budgets, performance-based percentage increases in the last contract, revising the supplementals (ongoing), and adding paternity leave. He's also proud of all the times when he has helped members resolve conflicts with the administration, as a building representative, PR&R chair, and through the grievance process. Finally, Mike is proud to have taken part in the fight against SB 5 and Issue 2 in 2011 with We Are Ohio and the rally Eileen Sweeney spearheaded. He feels that helping overturn that law was a major achievement by all of us. Mike is the proud father of three children, 12, 10, and 6, who attend the Cleveland Heights-University Heights schools. His wife, Kristen Roope, is a 17-year member of the SHTA. She is a library media specialist at Boulevard and Fernway.

Lifetime Award Winner Tom Patrick taught High School Mathematics for thirty-six years and one year as a retiree. Tom also served as treasurer for the SHTA for 32 years. 
In order to receive reimbursement this school year, your documentation must be submitted to me by May 22. Payments will not be made over the summer break. Reimbursements will resume in the fall.

#### TREASURER'S REPORT

The Investments Committee (made up of myself, Matt Zucca, Chante Thomas-Taylor, and Todd Keitlen) met on May 3<sup>rd</sup> with Brady Krebs, our Edward Jones advisor, to go over the Association's investments.

Before the May Executive Board meeting I prepared a budget for the 2017-18 fiscal year. I presented that budget to the Executive Board. The Executive Board approved the budget for presentation to the Representative Council the following week. The Representative Council discussed the budget at the May  $8^{th}$  meeting and voted to have the budget reflect a 4% increase to the salaries of the six salaried Association employees. The Council voted to increase the per meeting remuneration by 4% as well. The budget was then approved for placing on the May  $22^{nd}$  ballot.

The current financial report is included.

Some of the activities I performed while fulfilling my duties as Treasurer this year are listed below:

- I attended every Executive Board Meeting and every Representative Council Meeting throughout the year.
- I maintained our insurance through Musgrave Insurance.
- I met with the Investment Committee and Brady Krebs, our Edward Jones advisor, twice this year, once in the fall and once in the spring to evaluate our Edward Jones investments and make changes that were deemed necessary.
- I met with representatives from Key Bank to monitor our investments of Association funds.
- I met with our accountants at Edward Hawkins & Co. at various times throughout the year to submit our books for a compilation process, to complete the paperwork for our Form 990 tax filing, and to submit information for the issuance of W-2 forms.
- I processed money from SHTA members into the SHTA PAC account and used it to make a contribution to the Shaker Levy Fund.
- I communicated with the Shaker Heights Board Office to pay the salaries of our six paid Officers and Committee Heads along with the relevant STRS and Medicare payments.
- I paid the SHTA Representatives their compensation for attending the meetings throughout the year.
- I prepared the 2015-16 fiscal year budget for approval by the Representative Council at the May Association meeting.
- I was lucky enough to be the one who notified Tom Patrick (former treasurer) of his Lifetime Service Award.
- I attended SHTA social events.
- I attended a protest rally at Rob Portman's office opposing the approval of Betsy Devos as the U.S. Secretary of Education.
- I marched downtown with fellow teachers and Mark Freeman (our former Superintendant) at the March for Science on April 22<sup>nd</sup>.
- I attended various community meetings sometimes serving as an SHTA representative.
- I paid bills throughout the year and balanced the checkbook, reimbursing any Association expenses incurred by our members.
- I kept accurate record of our finances throughout the year, maintaining a paper record of every transaction.
- I met with and discussed Association business with the other Officers and Executive Board members throughout the year when needed.

Looking back on this year makes me so appreciative of the work my colleagues do. I'm speaking specifically here of my SHTA colleagues. They keep me informed of what's going on nationally, at the state level, and here in our own district. They are guardians of our contract ensuring that the administration abides by it. They help our new teachers get through the hellish Resident Educator program enabling them to become quality Shaker educators. They keep an eye on all teacher evaluations allowing people to be reassured they will be treated fairly. They negotiate for a strong contract so all the district's teachers can feel secure in their livelihood. They provide moral support to district staff. I really am grateful for all the work the Association does. Thank you to everyone who helps me do what I love most - working with our students.

# EXECUTIVE BOARD REPORTS

#### PROFESSIONAL RIGHTS AND RESPONSIBILITIES REPORT

The 2016-17 school year was a relatively smooth one. I continued to assist members with questions about maternity leave, medical leave, health insurance, paternity leave, sick days, and personal days. My involvement with both the Insurance Committee and the Supplemental Committee kept me busy throughout the winter and spring.

I wrote Grievance 17.01 regarding standardized testing at the middle school. A hearing on April 24 went well. The administration agreed with many of the actions requested by the members. A new testing committee will assist with all future planning and implementation of standardized assessments at the middle school.

In my May, 2016 report I wrote about equity. The district is now working on an Equity Task Force that will study the issue and make recommendations. The voters of Shaker Heights voted for the bond issue, which will make it possible to make necessary improvements to buildings across the district. Director of Professional Learning Erin Herbruck gave an excellent presentation on May 8 about teachers becoming Google certified. Technology can be a tool to help us achieve equity. I encourage all members to take advantage of this opportunity to use Google classroom to reach more students. New Director of Pupil Services Elizabeth A. Kimmel has experience implementing intervention programs for reading and math in Lakewood City Schools. Lakewood regularly exceeded their "Value-Added" component on their state report card in recent years. We are working hard to make sure every student succeeds.

I also try to highlight pertinent articles and by-laws from our constitution in our monthly newsletter and keep members informed of changes concerning tenure, SHTA ST, and our responsibilities as members of the Association.

Other activities include my continued participation as a member of the Teacher Evaluation Committee, as well as the support of our members in my respective buildings.

#### LEGISLATIVE COMMITTEE

Over the past year, I have monitored the legislative and political appointments, proposed bill, budgets and elections at the state and local levels. I encouraged our membership to exercise their right to contact their elected officials to voice their opinions on issues impacting education.

I have followed and informed the membership about the following issues:

- A state hearing officer has ruled that the ECOT online charter school still <u>owes the state \$60 million</u>, denying an administrative appeal of an audit that found the school was overpaid last school year. After ECOT lost a case in Franklin County Common Pleas Court last year to block the review, it appealed that ruling to the 10th Ohio District Court of Appeals. A court appeal is also still pending.
- Ohio is developing a plan for the new Every Student Succeeds Act (ESSA), specifically how our local, state and federal programs are aligned to help all of our students be successful. Visit the Ohio Department of Education webpage for more information. <a href="http://education.ohio.gov/Topics/Every-Student-Succeeds-Act-ESSA">http://education.ohio.gov/Topics/Every-Student-Succeeds-Act-ESSA</a>
- The general election results from November of 2017 brought in the Trump administration and the appointment of Betsy DeVos as Secretary of Education.
- Ohio Department of Education (ODE) officials encouraged local education leaders to participate in policy discussions during State Board of Education meetings and legislative sessions. Now, the ODE does not encourage local school leaders to frequent the Statehouse nor seek their input.
- House Bill 53, a version of "Right to Work" law, was proposed by Ohio Representative John Becker, of Union Township.
- The Supreme Court's ruling on *Endrew F. v. Douglas County School District* (2017) and its' impact on all school districts regarding services for students with special needs.
- The expansion of state vouchers and the funding of charter schools.
- Governor Kasich proposed a requirement that, as part of the teacher license renewal, all teachers must complete on site work experience with a local business or chamber of commerce. This has been since removed from House Bill 49.
- Changes to the principal and teacher evaluations.

I have spent months serving on the Supplemental Compensation Committee to negotiate a scale of compensation that reflects parity and transparency for supplemental contracts. It is our hope that will be a Memorandum of Understanding for this area outlined in the side-letter of our contract. We have yet to tackle negotiations regarding unit pay. I attended 10 association meetings and a few board of education meetings.

Congratulations to all of you!

The main purpose of the Teacher Education Committee is to be a liaison for newly hired and non-tenured teachers. Throughout the year, I answered questions from teachers to help their understanding of requirements needed to obtain a continuing contract in our school district. I created an information packet that was distributed at the September New Teacher meeting. Within this information, I addressed specific parts of the SHTA contract that were especially important to new teachers and those without a continuing contract.

I have been communicating with Director of Professional Learning Erin Herbruck and SHTA President John Morris regarding the protocol and expectations for student teachers that wish to complete their student teaching experience in Shaker Heights Schools. The following is the clarification from Dr. Herbruck:

- 1. The administrator should ask for staff willing to volunteer-this should not be required. The District is not obligated to place every request. However, efforts should be made to support the ongoing success of the profession and our collaboration with teacher education institutions.
- 2. First preference should be given to continuing contract teachers who would best serve as a mentor (cooperating) teachers.
- 3 If a limited contract teacher is interested and he/she is a best fit, ongoing building level administrative support for the placement is requested, so that any issues that may arise for the limited contract teacher are collaboratively addressed.
- One practice that buildings/teachers have been implementing is to have the potential mentor (cooperating) teacher (and an administrator, especially in the case of a placement with a limited contract teacher) meet with the potential student teacher for an informal interview. If this is of interest, the Professional Learning Department is happy to help facilitate this process with the college/university.
- 5 Please note: The model for student teaching has evolved- it is much more of a co-teaching model. The student teacher should not be alone in the classroom with students for extended periods of time. The mentor (cooperating) teacher should gradually release instructional leadership to the student teacher over time, and the student teacher will become the head teacher. During the full student teaching, the mentor teacher serves as a co-teacher/support.

I feel that even though I am an experienced teacher, there are always fresh ideas to learn from newer teachers. As educators, we should never stop learning. Thank you for this opportunity to work on behalf of the Association. Wishing you a calm end-of-the-year and an enjoyable summer!

### May 8, 2017, Onaway School

SHTA President, John Morris started the May 08th Rep. Council Meeting at 4:30PM.

Eric Forman, Principal of Onaway Elementary School welcomed Rep. Council to Onaway. He stated that it has been an awesome year at Onaway Elementary School.

**MINUTES** from the April 10<sup>th</sup>, 2017 Rep. Council meeting were approved, motion made by Bonnie Gordon and seconded by Aimee Grey.

#### **Administration Report**

Dr. Erin Herbruck, Director of Professional Learning was present from central office.

- Dr. Herbruck shared information pertaining to the Google initiative for educators. There will be 3-options for teachers to complete Google professional learning.
  - Option 1 Google users that have a basic level of knowledge. If you know less than 10% about Google, Boot Camp is for you.

- When writing SLOs, teachers were asked to document the amount of growth recommended or projected for their students and to back with research. As stated by one of our unit teachers: our students all have multiple disabilities and there are no two the same, affecting growth measurement data. They all require an Individualized Education Program in order for them to access curriculum and extended Ohio learning standards. The accommodations and modifications each student requires are unique to them and beyond those accepted by the state of Ohio on standardized testing.

• Our hope is for our students and teachers in our MD units to have a consistent set of expectations before each school year begins, as well as establishing the best assessment and monitoring process of growth for each student, in each unit--exploring other options other than SLOs.

#### Reflections from a Shaker Teacher

The recent mayhem surrounding the administrative decision to remove the K-4 Science lab experience and dedicated teacher has had me thinking a lot about my place in the universe lately. One might ask, what does elementary science have anything to do with me, an English teacher at the high school? Here's my answer: plenty.

Any of us who work in Shaker have a vested interest in the entire district. Student success in high school depends significantly on the experiences they have prior to ninth grade. And for those of us who work and live in Shaker, our involvement is even more personal. Having chosen to educate our children here, we want them to have an array of enriching and awesome experiences both in and out of the classroom.

In full disclosure, I have bled Shaker blood long before many people reading this were born (sigh), from my first day of kindergarten at what was then Sussex school to my tenure as a teacher to my concurrent pride and joy as a Shaker parent. To me, Shaker means asking questions, expressing ideas, exploring options, having discussions, finding solutions. Those solutions may not satisfy all parties, but they are the result of thoughtful and engaged discourse, with all parties sharing honest and clear information and working toward the best possible outcome. Ultimately, even if everyone does not agree, everyone respects each other and understands how and why the decisions have been made. And we are all better for having participated in the process. (Ironically, this sequence is very similar to the scientific method that will no longer be featured in the same way for our pre-Kindergarten-4<sup>th</sup>-graders).

Nevertheless, I am not here to debate the decision made by the administration about how science will be taught moving forward. I am not here to share my opinion about what should have happened or what should happen moving forward.

I am here to share, however, that *my heart has been broken* by what I've witnessed. Here we are, a passionate, dedicated, and thoughtful collection of professionals who don't feel like our opinions matter. For example, rather than praise the fact that several teachers (many of whom also wear hats as residents and parents) attended a weekend discussion, the teachers' presence was seen as antagonistic. We have somehow become "those teachers who don't want to change;" "those teachers who need to look at the data;" "those teachers who just need to do what they're told because we know best"; or "those teachers who are just being contrarian."

Even *more heartbreaking* is the aura of fear that this incident has brought to the surface. How many discussions have occurred with people wondering whether signing a petition or sending a letter would have "repercussions" on them or their spouses? How many reached out to parents but asked them not to use their names? How many felt worried about attending a meeting? How have we all landed in a situation where asking genuine questions about what's best for the children who live in this district might lead to punishment? I am sure that some who read this paragraph will scoff at this claim, saying that we teachers are being paranoid and overreacting. But here's the thing; if people feel it, then it's real. I have to believe that this atmosphere is not what anyone really wanted, but it's what we've now got. To repeat, it's real.

And the *biggest heartbreak of all* is going to be if the collective Shaker community that consists of teachers, parents, administrators, board members, and students continues to operate in this way. Ruling by and living in fear, while perhaps efficient in the short run have never yielded great results. When people stop feeling like they have the power to make a difference and settle into doing what they're told, we all suffer. That being

said, having the courage to reject the status quo isn't easy either, and yes, it often has consequences attached to it. Moving forward, I guess we will each have to decide what our own personal tipping point is. And it sure would be great if those who are the source of the fear would be willing to honestly acknowledge that we have some real issues and come to the table and try to address them.

Some helped teachers better instruct their students but many were bureaucratic in nature.

Now, of course, paperwork and documentation has always been a part of our job; however, are **all** of these requirements **essential**? *Do they improve our interactions with our students*? Remember, each of these added obligations takes time away from work we could be doing with students and their families. In business, there would be a cost/benefit analysis. I had hoped we can begin a dialogue about the items that are unproductive and even wasteful. We are paid for our expertise as educators. Let's make sure our skills are being used effectively.
