Message From the President

In the Spring of 2010, I saw my own death. It may sound overly dramatic, but it is absolutely true. I was teaching my 2nd period American Experience class in our double class configuration. and at approximately 9:30 we went into lockdown. Apparently, a person had called the Shaker Heights Police Department having witnessed an unidentified individual enter the front of the school with an unidentified object in their hand while the doors had been propped open to accommodate a sick student who was being taken out in an ambulance on a stretcher. For the next nearly 120 minutes, we went into lockdown.

This was during the era before text alerts and all district emails, before discussions of ALICE training and district-wide evacuations. In fact, we were instructed to turn our computers off and ask students to stay off their phones. I remember it was particularly difficult because one of my students had received a text that had simply said “goodbye” shortly after the lockdown began, causing panic among the group of students who had seen the text. Likewise, students had received texts from Beachwood and Cleveland Heights describing the imminent, although unfounded, threat at SHHS. In such a high-tension environment, the “no cell phone policy” was impossible to enforce. Students sat along the walls, beneath the sightlines of our windows, with the lights turned off, on each side of our large double class room. My teaching partner at the time and I tried to keep the students calm as they sat along the wall, away from the windows, while some quietly cried and one began to hyperventilate. After the first hour, we even began to debate which trashcan would be used if students needed to relieve themselves and which to use if they became sick.

During previous discussions of a lockdown, we had been assured that security guards or police officers would slip an identification card under the door if they needed to come into the room. Otherwise, we were instructed to keep the door locked and not allow anyone in. We were also instructed to place a green “all clear” sign in our door window, or a red “danger” if things were amiss. This obscured our vision of who was in the hallway as well. At nearly two hours in, I began to hear noise in the hallway. It sounded like a person or people moving rapidly outside our door. The door handle began to move. I asked, loudly, “Who is it?!?” No response. The door handle was being violently moved up and down. Students began grabbing books to throw at an intruder. I asked, loudly, “Please show some ID!” Someone in the hall yelled, “Open up!” Not knowing if this was an officer or an individual attempting to impersonate an officer, I began pushing desks, throwing them, against the door. As the door opened, three swat team members entered the room with their guns drawn. The kids collectively cried out in relief.

At that moment, I saw my death and I was at peace with it. If I had to die to give my students the time to get out of our second story window, it would have been worth it. However, I can't imagine how traumatized they would be. I couldn't imagine how my absence would devastate my family. But I did know that in 2010, in a Post-Columbine United States, this was the world I was facing. Sadly, since then, we have had school shootings seemingly without number. From Chardon to Sandy Hook to Marjory Stoneman Douglas High School in Parkland, Florida, we have not solved the continuing tragedy of school shootings. And I think we are all at a collective loss fueled by our own numbness.

Thankfully, a new generation of student activists have been born from the tragedy at Marjory Stoneman Douglas High School and the #NeverAgain movement. They are unwilling to stay passive and be overwhelmed by the gun lobby. They are taking on the National Rifle Association and politicians tone deaf on the issue of gun control. They refuse the veneer of "thoughts and prayers" and are calling for direct action from everywhere from their own schools to the steps of Congress in Washington, D.C. We are fortunate to have many of these motivated students at Shaker Heights Schools as well. That is why we so enthusiastically have endorsed and supported the students who walked out on Wednesday, March 14th at 10:00 AM for 17 minutes, in honor of the 17 students and faculty killed in Parkland, Florida. We are here to support our students and honor their voices calling for change. Likewise, it's time for us to advocate for common sense gun reform that will keep guns out of the hands of students. It's not fair that this generation of young teachers, like the students they have been trained to educate, must add "human shield" to their job descriptions. I may have been forced to come to peace with my own possible demise at the hands of a school shooter. They shouldn't have to do the same. Let's work together with our students, our community, and our administration to make sure this is a future goal that we can collectively embrace.

It's been a quite a month. I solicited committee members for the districts "Go Green" initiative I addressed safety concerns after the 2/22 social media threat. I attended meeting with students, city council, PTO, board members, police, fire and administration on the March 14th Walkout at 10 am. I wrote an email explaining the walkout. I updated the SHTA and CCES Facebook pages. I reached out to CCES about March 14th. I reached out to Beachwood about March 14th as well. I dealt with a personnel issue at Woodbury. I worked with our PAC Chair, Cathy Grieshop, and High School Representative Aimee Grey on letter writing campaign concerning gun control. I attended HR director interviews. I dealt with a staffing issue at the HS. I consulted on a safety issue at Mercer. I consulted on a contract issue at the Middle School. I conferred on a supplemental issue at the High School. I worked on SHTA ST contract negotiations preparation with Bonnie Gordon. I fielded pay increase questions. I attended a Labor /Management meeting for SHTA ST with Dr. Cavucci and Bonnie Gordon on March 7th. I attended *A Night for the Red and White* on Saturday, March 10th. I addressed a safety concern at the High School. I attended the State of the Schools address on Thursday, March 15th. As always, it is a pleasure to serve you as SHTA President. 

EXECUTIVE BOARD REPORTS

PROFESSIONAL RIGHTS AND RESPONSIBILITIES REPORT

John Morris invited me to a meeting at the high school on February 22 about the National Student Walkout. During the meeting, high school students shared concerns about the need for more timely and detailed messages regarding student safety. Both city and school district leaders agreed to support student efforts to organize protests about gun laws. I participated in the walkout at the Middle School and am happy to report that it went well. I assisted a member with a step 1 grievance regarding payment for lost planning time. I worked with Middle School head building representative John Koppitch on a step 1 grievance regarding both specific student discipline issues and general school policies regarding student discipline. The response from the Middle School administration was satisfactory. There is a follow up meeting scheduled for March 20 to start working on an action plan. I am also helping a member with maternity leave and caregiver leave. I advised a member of another bargaining unit about a health insurance matter. I recommend using your Medical Mutual card to set up an online account. I also suggest calling them if you have specific questions about a claim, denial, or change from Anthem. They are supposed to be providing the same coverages as Anthem. The Insurance Committee meeting scheduled for March 8 was postponed until March 22.

LEGISLATIVE COMMITTEE

Where the educational world meets the legislative world, the news has been almost entirely about the variety of plans for coping with the school shooting in Florida. Although hugely important, it seems too early to say much about the likely direction that our local, state, and federal governments might take, so this committee will report on this issue when some concrete steps are closer to being taken.

In contrast with the cloudy future of guns in schools, the case of *Janus v. AFSCME* has now been heard by the Supreme Court. As the National Educational Association reports (<http://neatoday.org/2018/02/15/how-janus-case-threatens-working-people/>), this is the Supreme Court case that could make “right-to-work” the law for the entire public sector of the country. Currently, when a union of public employees does work that benefits a nonmember, the union is allowed to charge the non-member a fee for that work. The most common example of this kind of work is the negotiation of a contract, and that fee is sometimes called a “fair share”. This is more than about money really; if this case goes against unions of public employees, then it will severely diminish their political power (and that is why the *Janus* side of the case is being funded by very wealthy people). Expect a decision in May or June.

As Every Student Succeeds Act (ESSA) continues to roll out as federal law, changes are still happening. Recently, the states that have not received approval for their plans have been given extensions (http://blogs.edweek.org/edweek/state_edwatch/2018/02/sevent.html?cmp=eml-enl-eu-news3&M=58389726&U=2641459). ESSA is especially contentious in Florida, where the state wants to not include the test scores of specific groups of students into the measurement of school quality (something not allowed under the federal law).

If you know of an education issue that is in transition in the legislative world, please let the Legislative Committee of the SHTA know about it.

Now that new teachers are subject to as long as a seven-year waiting period before receiving a continuing contract, the language in our constitution requiring a continuing contract to, for instance, become a building representative, had to be changed in order to let newer members have a stronger voice in our association's activities.

ARTICLE VIII section B states: *Any member who has been a member for the three years immediately preceding the election or appointment shall be eligible to be a member of the Representative Council.*

- I attended *A Night for the Red & White* and hopefully represented Our Association well.
- Mr. Kuehnle has asked faculty members to respect the posted signs for fire lanes and to not park illegally in the parking lots. I have also asked him to follow up with SHPD to ticket student cars that are parked in the area reserved for faculty parking along the north side of the Oval near the North Gym.
- Administration has asked for our cooperation with ID sweeps that they plan on conducting sometime in the near future. More communication will come from the Administration on the sweeps in the future.
- We dealt with several different schedules in one week (2/26-3/2) and had several complaints from teachers regarding the late notice about the ACT/PSAT schedule and the assembly for the State of the Schools.
- The Study Center position that was staffed has been vacant for a month and continues to be staffed by substitutes. It was reported to me that the Study Center had no coverage on at least two occasions during this time. The administration needs a permanent solution to this issue, and we cannot have this piece meal coverage as a part of our plan for next year's staffing.
- I worked with the Administration to help determine a plan for students and teachers during our Walk-out on March 14th.
- There have been issues regarding payment of EOC tutors for work completed in the Fall and concern about how EOC tutors would be paid for future work. We believe that both issues have been resolved. I wanted to remind all of our members to be certain that you have an agreement for payment in writing from the Administration before beginning any work outside of your normal contracted duties. Without a written contract or agreement, there is a risk that the terms of your payment could change after the work is complete.
- There has been a proposal to change the format of our Final Exams that many teachers are opposed to for reasons such as grading time for exams, inequity of teacher workloads, and making our common assessments unusable due to the proposed timing of the exams. I will continue to meet with Mr. Kuehnle and Mr. Inman to resolve this issue.
- I have been working on an ongoing issue involving a member who is being harassed by a student. We continue to seek resolution of this issue.
- Member-posed question: Has there been a concerted effort to reduce the number of suspensions, regardless of infractions?
- Concern with scheduling of April Faculty PD- encouragement by Principal Kuehnle to attend this 90-minute training which will end at 4:35PM (35 minutes past contract day). While his email acknowledged staff could leave at 4PM, some staff feel this sends the message that sexual harassment training is somewhat optimal or unimportant.

- Concern that financial considerations are driving scheduling in terms of sections being reduced, which results necessarily in class size increasing.

Old Business

- None to report.

New Business

- Attended Moms Demand Action for Gun Sense. Teachers from every building were present. Encouraging educators for demanding action. Group/Committee could use help with this.

There have been many ideas floating around in response to the latest school shooting tragedy in Parkland. The answer is not increased security teams, installing ten-foot barbed wire fences with guard towers in the corners, police officers patrolling the halls, metal detectors at doors or arming teachers to shoot people, potential former students. Districts have long been stripping away the services from the schools in an attempt to streamline the schools, appease hawkish school boards and residents, and to get more with less. Our children are getting less with less. We have limited, if any, wrap around services for children who are in desperate need of help. As a society, we don't address the cause of a problem, we just address the symptoms. Just look at the opioid epidemic for a perfect example. Stop the pain but don't look at what is causing it. Our society runs at such a frenetic pace, we don't value looking deeply for the root of the problem, we just react to the disasters that unfold due to them. The children in our rooms now go un-helped because teachers are asked to do so much more with so much less at such a fast pace. Our emotionally hurt and challenged students need more than what a spread thin staff can give them. We have failed long before one of these children has an idea to bring a gun to a school let alone actually shoot. Statistics show that many of the school shootings are perpetrated by current or former students of the school. We have failed them while they were in our care. Instead of looking at ways to eliminate teachers, psychologists, guidance counselors, nurses, aides, support teachers; we need to add more. Our children need them, their lives depend on them. Arm me with caring taxpayers, compassionate school leaders, more staff, and resources to help our children.

HOW TO REALLY END SCHOOL SHOOTINGS

The massacre at Marjory Stoneman Douglas High School, another school shooting in a long line of them, has once again led to debate on gun violence, gun access, mental health and school safety. The accused shooter, a former student who felt disenfranchised and estranged from the school community. He was able to get a hold of military style assault weapons to rain death down on the school.

Since then we have heard of many solutions and the Florida legislature has actually put in place some of these ideas, including arming school personnel, raising the age of gun purchasing to 21 years of age, and requiring a three-day waiting period for most gun purchases. Would this have stopped the massacre in Parkland, Florida or before that at the Pulse Nightclub in Orlando? As many states, including Florida and Ohio, have widened access to guns, allowed for guns to be brought into more public spaces and at the same time opened many loopholes in gun registration, we will have to see if these new restrictions will lead to meaningful changes.

I would like to propose another solution. Why not get to the problem before it festers? At the March SHTA Executive Board meeting, during a discussion on current legislation being sought to stop school shootings, SHTA Vice President Matt Zucca spoke eloquently about a transformative idea. The vast majority of school shooters are current or former students of that school. Instead of arming teachers with guns, an idea only good for the gun manufacturing industry, why not arm them with tools to reach all students and connect them to the school, so the urge to harm and kill is instead channeled into productive uses?

Journalist Dahlia Lithwick of Slate magazine wrote about how the students of Marjory Stoneman Douglas High School were able to rally against gun violence so quickly after the shooting (<https://slate.com/news-and-politics/2018/02/the-student-activists-of-marjory-stoneman-douglas-high-demonstrate-the-power-of-a-full-education.html>). Her article focused on how a well-rounded education that had multiple opportunities for students to gain skills and knowledge outside the basics, allowed the students to confront this tragedy with courage and a strong voice. Lithwick states “The student leaders of the #NeverAgain revolt were also, in large part, theater kids who had benefited from the school’s exceptional drama program.” Journalism, debate, theater, the arts and music helped develop well rounded students that when called to action have the skills to do so.

Sadly, the administration of Shaker Heights City Schools has begun to move away from that model. During the recent recession, the District was vigilant about reducing costs through attrition. This allowed teachers to keep their jobs and to save costs through not hiring certain positions after people retired. The idea worked in saving jobs but meant larger class sizes. Since then, the return to pre-recession staffing levels has never occurred and class sizes remains high throughout the district (a major reason some residents have chosen private schools over ours). Class size is immensely important in building relationships with our students. Having time to get to know and understand each child allows us to better respond to their needs and catch them if they fall. With the additional duties, reduction in staff, the increase in I.B. training, Google certification training, and the myriad of other mandates, teachers have less time with their students, leading to greater isolation from the school and the school community.

In the past five years, both state and [district mandated tests](#) have also increased greatly. At Shaker Heights High School, we have added seven End of Course Exams (State Mandated), the PSAT for both 10th and 11th grades (district mandated), the ACT for 11th grade (State Sponsored but not mandated) and starting this year two MAP tests in 9th grade (district mandated). The stakes are high on these tests. Students are taught by the adults in their lives that they must pass these tests to graduate, get into a good college and be successful. What I have personally seen in the nineteen years of teaching is an increase in anxiety, and reduction in spirit of exploration of our students. They want to know the right answer. They need to get the best grades on assignments. They fear being wrong. School should be a safe environment to fail because that is how we learn.

The reduction of staff has also affected the arts, theater and other supposed non-academic courses. Art teachers in the elementary see their students once a week and now must travel to multiple buildings. Theater classes at the high school have been dropped because they did not meet the administration minimum of fifteen student per class, a bureaucratic formula that fails to understand the nature of certain classes. English teachers at the high school have been assigned to teach an additional class each day, meaning less time for assigning and grading essays, a Shaker standard that has led to nationally recognized writers. Even now, teachers are fighting for another section of the Writer’s Center at the high school, a successful system where students are trained to help other students in their writing. Yet the outgoing superintendent continues to remark about a reduction of staff because of a reduction of students. Does this make sense in an era where we need greater engagement with students?

I am fully aware that the residents of Shaker Heights pay a much higher than average property tax. I am also fully aware the Board of Education and administration need to be able to justify the costs of a Shaker

Education to their constituents. I also know that one third of the faculty and staff of the school district chose to live in Shaker Heights. I know that a large portion of the residents have advanced degrees and are education advocates. The residents of Shaker Heights expect a high quality and well-rounded education and are willing to pay a fair amount to have it. While they are cost conscious, they are understanding of the demands of a high level education. In general, the faculty has delivered on their demands. We have negotiated time to meet with students, we have advised student created clubs and activities, we have adapted to changing technologies, we have created amazing opportunities for our students to shine inside the schools, in the community and to a broader audience. Yet we still need more time and resources for our students. We need time to reach the quiet student in the corner and get to know her. We need greater access to reading specialist to help students reach grade level. We need more counselors, social workers, psychologists etc. at all grade levels. We need access to quality health, emotional, and social support agencies within the community. We need social workers will to help students with anger management issues. We need time to build community in our classrooms and in the schools. We need lower class sizes to allow this to begin to happen.

How do we end school shootings? We may never end all school shootings but if we can reach one student, whose path may have diverted from a more troubled life, is that not the beginning? Arm me with time and resources, not guns and fear.
