TREASURER'S REPORT

Before the May Executive Board meeting, I prepared a budget for the 2012-13 fiscal year. I presented that budget with zeros written in for salaries at that meeting. The Executive Board approved the budget for presentation to the Representative Council the following week. The Representative Council discussed the budget and voted to maintain the officers' and paid Committee heads' salaries at the level they were for the 2011-12 fiscal year. The budget was then approved for placing on the May 21st ballot.

The budget you voted on this May is getting closer and closer to the limit of our dues income. The excess not spent at the end of the year from the budget traditionally goes toward building our general fund. We have not had any money to add to it in recent years. The general fund is what gives us strength when we go to the negotiating table and it is in our collective best interest to contribute to its growth. A vote on a dues increase may be in order in the near future. The current financial report is included.

Some of the activities I performed while fulfilling my duties as Treasurer this year are listed below:

- I attended every Executive Board meetings and every Representative Council meetings throughout the year.
- I maintained our insurance through Musgrave Insurance.
- I met with the Investments Committee and Brady Krebs, our Edward Jones advisor, twice this year, once in the Fall and once in the Spring, to evaluate our Edward Jones investments and make changes that were deemed necessary.
- I met with our accountants at Edward Hawkins & Co. to prepare for the compilation of our 2010-11 financial books. I also met with them to complete the paperwork for our Form 990 tax filing.

- I managed our Key bank account depositing our membership dues and paying bills throughout the year.
- I communicated with the Shaker Heights Board Office to pay the salaries of our six paid Officers and Committee Heads, along with the relevant STRS and Medicare payments.
- I paid the SHTA Representatives their compensation for attending the meetings throughout the year.
- I prepared the 2012-13 fiscal year budget for approval by the Representative Council at the May Association meeting.
- I paid bills throughout the year and balanced the checkbook, reimbursing any Association expenses incurred by our members.
- I kept accurate record of our finances throughout the year.
- I met with and discussed Association business with the other Officers and Executive Board members throughout the year when needed.
- I opened a new bank account titled "PAC of SHTA." I collected the money contributed to this account, deposited it, and then worked with the PAC to distribute funds when necessary.
- I went down to Columbus to protest Senate Bill 5, filled a number of petitions to get the law placed on the ballot, attended a number of anti-SB5 rallies, made phone calls for the campaign, canvassed houses, and worked the polls on election day.

I enjoy the work I perform for the members of the Association. I get satisfaction out of being able to indirectly help each member in a small way. I thank you for giving me this opportunity. I hope everyone has had a nice year, and has an even better summer.

PROFESSIONAL RIGHTS AND RESPONSIBILITIES

John Morris and I met with Bryan Christman about health insurance matters. Anthem made some minor changes to our plan, which will not affect most of us. However, if you discover that a procedure that used to be covered no longer is, you should contact Sue Garber (x4318) immediately. The administration has agreed to work with Anthem and make sure members who were receiving these treatments before the changes are still covered in full.

Along with several members of the Executive Board, I attended the public viewing of *American Teacher* at the high school on May 10. I found myself nodding my head in agreement at many of the comments made by the teachers. I was most saddened by the number of teachers who choose to leave the profession within the first few years because of the high demands of the job compared to the relatively low salaries and benefits. While we are lucky to have a lower turnover rate here in Shaker Heights, that could change. Our association and administration must continue to work diligently to make sure we are following both the letter and the spirit of the contract. As extra duties and meetings have been added to our workload, I've heard from several members who are frustrated by the lost instructional and planning time. We will continue to monitor this situation. Thanks to Andrew Glasier and Eileen Sweeney for planning this event.

Lisa Howell and I discussed the final postings for the 2012-2013 job shares. I assisted a couple members who had questions about job sharing. I also worked with members on maternity leave questions and summer work obligations. Please remember that you are not required to do any work outside of contract hours. However, if a member chooses to work outside of the contract that is their individual choice. We all work outside of the contract every day to prepare lessons and grade papers and make sure that our work during the contracted hours includes as much teaching and learning as possible. There may be situations when you are asked to complete a special project that requires many additional hours. In these cases, I recommend asking your building administrator for either release time, curriculum units for projects completed after hours, or summer writing units. If required tasks seem unreasonable, contact your head-building representative. If the problem continues, contact me.

End of the Year Report

The school year started with an amazing effort by teachers and many others to defeat Senate Bill 5/Issue 2 at the ballot in November. I was so happy to see more than 60 % of the voters say no to this unjust law. If it had not been repealed, I wouldn't be allowed to talk with Bryan Christman, Lisa Howell, or Sue Garber. We as an association would not be allowed to help our profession through collective bargaining. It was obviously a huge victory for teachers. The campaign led to a county wide union summit that John Morris and others have attended. This is an excellent opportunity for us to work together, be strong, and stand up for ourselves.

We did not file any grievances for the second year in a row. Many of the concerns brought to my attention by the membership were solved through meetings and conversations. These open lines of communication between the Association and the administration are so important. They allow us to move forward without having to go through the grievance procedure. I know some members feel that the administration is stretching the work rules in the contract toward a breaking point. I encourage anyone who thinks the contract is not being followed to contact me (x4770).

I also understand every school district is under pressure to comply with state and federal mandates like linkage (linking student test scores to a teacher's name to measure student growth for value added scores), a new evaluation system, and changes to the curriculum and OAA's. Fortunately, teachers are in the room on committees trying to figure out how to implement these changes. No one likes change, and we need to fight against some of these changes; but we are included in the process because we are on the front lines delivering instruction daily. We are the experts. If the state of Ohio ever attempts to deny our rights to collective

bargaining and/or due process in the future; I am confident we will stay strong, stand together, and fight for a seat at the table.

It is my pleasure to serve the Association and I look forward to next year. Take time to enjoy the summer.

SALARY TENURE COMMITTEE

In response to the Race to the Top program guidelines, the Evaluation Committee has drafted a modified version of our current evaluation system. The Ohio Standards for the Teaching Profession served as the foundation upon which the new system was developed. This revised system will be piloted next year and district wide implementation is scheduled for the 2013-2014 school year. Although, student assessment data is not currently part of our evaluation program, future state mandates may require the inclusion of this data in teacher evaluations.

The Performance Compensation Committee has made progress working towards designing and implementing a program, as required by the negotiated side letter, that was part of our most recent contract negotiations. We are currently working on designing a long-term mentor program to help new teachers. The possibility of using long-term mentors to assist struggling teachers is also being explored. Teachers interested in becoming a long-term mentor need to acquire their Master Teacher designation from the state. Teachers in this group will then have the opportunity to be part of a cohort of teachers to acquire a Teacher Leader License from John Carroll University. Erin Herbruck sent an email regarding this opportunity. Please contact Erin, or any committee member, with questions or interest.

I went over the Evaluation process for all new teachers and parts of the SHTA Contract.

The Evaluation process remains an area of focus for new and non-tenured teachers. Throughout the course of the school year, I kept all new and non-tenured teachers up to date with deadlines and lines of support that were available to them.

I have enjoyed this position as Teacher Education Chair. I feel that even though I am an experienced teacher, there are always new ideas to learn from less experienced teachers. As educators, we ~~too~~ should never

LEGISLATIVE COMMITTEE

Legislative Report: OH Senate Bill 316, CMSD, oh and by the way, what a year!

Governor Kasich's third-grade reading guarantee is the central piece of Senate Bill 316, which will be voted on next week, and is expected to pass easily. Known as the reading bill, Bill 316 has been controversial because it calls for retaining third-grade students who do not score well on the reading portion of the third-grade OAA. Kasich originally proposed that any student who scores below "proficient" be held back. The bill was amended in the Ohio House, and now, only the student scoring in the lowest tier ("limited") would be held back. According to the sponsors and supporters of this bill, the motivation behind it is a concern that Ohio students will not score as highly once the Common Core Standards are put into effect during the 2014-2015 school year. Whereas only roughly 13% of third grade students currently score below proficient on Ohio's scale of standards, it is projected that many more students would fail to meet the national benchmarks of the Common Core Standards. In addition to requiring that students be held back, the bill also establishes an intervention system for students struggling with reading as early as during Kindergarten. The bill will require districts to target students with reading problems as early as possible, and to provide tutoring for those students.

Difficulties continue for our colleagues in the Cleveland Municipal School District. Earlier this month, it was announced that 500 personnel would be laid off for the upcoming school year. The CTU (Cleveland Teacher's Union) is currently involved in contract negotiations, and is at the fact-finding stage at present. It is currently unclear as to how buildings will be staffed next year with such huge reductions, or how many, if any, teachers will be called back once negotiations are over. Meanwhile, earlier this month, Mayor Jackson, along with the leadership of the CMSD and CTU pitched his revised "Cleveland Plan" to state lawmakers. While the proposal was improved, it still establishes a new merit pay salary scale. Evaluations will be the biggest determining factor in merit pay. In addition, the plan will put forth a November levy to help the district with its \$66 million deficit. Teachers in other districts, like my home district in Brecksville-Broadview Heights (B-BH), are struggling through negotiations. In B-BH, the current board is proposing that the district go to the State minimum requirements for class sizes and planning time, to name a few. Their proposal includes cutting planning time to one period per day, increasing the teaching load to six classes, and asking staff to agree to substantial pay cut over the next few years. This will be my last legislative report for the foreseeable future. I am stepping down from my post for the reason that I'm just too busy (between taking classes and implementing IB, for a few reasons) to give it the increasing amount attention that I believe it merits. The game has changed to the degree that the SHTA saw fit this past year to establish the Political Action Committee. What worries me is that we have watched the climate of public opinion deteriorate in tandem with the economy. Do politicians speak for the people who elected them? Does the greater public feel as pessimistic about teachers and the public system as their elected voices would have us believe? These are all interesting, challenging, and trying questions. More than ever, it is vitally important that teachers be informed. While it's nice to read a legislative summary in your SHTA newsletter, each of us should make it your personal business to read up and keep up on proposed legislation that could and

will change the face of our daily experience. If you read something you do not like or something that is simply untrue about your profession or your district, do something! Write a letter to an editor, write to your state representatives, go to your local school board meetings, stand up to a friend or relative, just be heard! Our profession has been guilty of complacency for far too long. We have turned the other cheek on the belief that most everyone out there supports schools, and would never turn their collective back on its students or teachers. These past few years have shown that this is not the case. In a tough economy, we found teachers among the first to be publically dragged through the mud for job security, stable salaries and pensions. Only we can speak up for ourselves, and only we can truly advocate for the conditions within our reality. As I leave you, I ask you to please be an advocate for yourself, for your colleagues, for the kids, and for all of the truths that drew us here and fuel us to stay.

POLITICAL ACTION COMMITTEE OF SHTA

Unlike any year in the recent memory, our membership has learned the depth our collective character. We have faced the challenge from Governor Kasich and the Republican led congress that attempted to strip our collective bargaining rights. Now is the time to reflect on the impact of these events. What have we learned?

The fight against Senate Bill 5 has taught me the depths of our commitment to our rights to have the SHTA protect the rights of the individual teachers. I am richer to have walked door to door/side and by side with my fellow colleagues. I have realized our shared values in democracy and the foundations of our country. I have had the privilege to witness the perseverance and mettle of the SHTA teachers as they stood in the rain and held a sign, attended a rally or worked a phone bank until 9 o'clock at night to ensure that we defeated Senate Bill 5.

The funny thing is that all of the hours of work we as an association did to defeat Senate Bill 5 was about creating the best environment and conditions for our students to learn in. As teachers, we know that requiring merit pay will erode the collaborative environment of schools and the delivery of instruction. We know that the extreme cuts in the state budget have created a climate that values economics over experience and effective teaching. We know that experience in the classroom is essential to student achievement.

Issues impacting our students and teachers are being currently proposed and debated in the Senate. Senate Bill 316, the education Mid-Biennium Review legislation, contains many education related policy changes of importance to SHTA members. Of particular concern is a provision that makes changes to the teacher evaluation statute that was passed under House Bill 153. The bill states that the statutory requirements regarding teacher evaluations prevail over any conflicting provisions of a collective bargaining agreement entered into on or after September 29, 2011. Simply, this language would significantly restrict the voice of teachers in the development and implementation of locally-adopted teacher evaluation frameworks. Please write your state legislator and urge them to oppose this provision in State Bill 316.

I am proud of the accomplishments of our association over the past year. The work we have done is essential in this new political climate. This perilous climate requires more

from each of us. As professionals, our role demands that we actively advocate for our students by protecting the rights of teachers. We are our student's voice. I encourage all of our members to continue to stay abreast of issues that impact the education profession and our teaching rights. Continue to stand as one.

How Can You Add My Value?

The United States Secretary of Education Arne Duncan was never a teacher. The only educational job he had prior to becoming Secretary was superintendent of Chicago Public Schools, which has a dubious record at best. President Barack Obama attended private schools in Indonesia and Hawaii. Both Sasha and Malia Obama have only attended private schools both in Chicago and in Washington, D.C. John Kasich's two daughters attend a private Christian school in Worthington, Ohio. These three individuals are in charge of our profession. Yet none of them clearly understands public education. This is most evident as we continue to implement the madness of Race to the Top (RttT) through serious unfunded mandates that impose frightening regulations on teachers. As our district continues to grapple with the monstrosity, we as true educators need to fight back.

Part of our evaluation system will be based on student test scores. The state of Ohio in its foolishness has agreed to make 50% of our evaluation based on student test scores. What that will look like not even the Ohio Department of Education (ODE) knows. How will we evaluate nurses, librarians, art teachers, etc... on student test scores? No matter. The ODE has sent the district a list of privately manufactured tests that they would find acceptable, a boon for Prentice Hall and Education Testing Services, companies that continue to lobby government for more "accountability" of public education.

The administration and the Association are currently grappling with the new Value Added component as part of receiving the RttT monies (for our district, a little over \$400,000 over five years). This will require we link individual student test performance to their teachers. Currently this linkage will be based on student performance on Ohio Achievement Tests (OAT). The linkage data is being designed by Battelle for Kids, a non-profit linked to the business Battelle, whose board of directors are mostly CEOs in some of Ohio's largest firms. While the ODE states that the information should be used to help teachers identify student issues, the Plain Dealer has already requested the data from districts that have gone through the process. In Los Angeles public schools, the newspapers have already published online teachers ratings based on linked Value Added scores. This **is** a public flogging of teachers based on inaccurate data. The simple mathematic formulas of Value Added cannot truly indicate the complexity of any child. Much like the state-mandated tests we currently administer, these test scores will be used only to punish those in poverty and the teachers that serve them.

And there will be more idiocy coming. School choice legislation continues in the Ohio House of Representatives, possibly taking much needed funds away from public education. More accountability in the form of mindless, unfunded, mandated testing which helps neither educators or children strive to succeed and is antithetical to good teaching is being considered. Of course the state legislature continues to defy the Ohio Supreme Court by ignoring the DeRolph decision and allowing the current funding practice of public education to be unconstitutional.

As a teacher thirteen years into my profession I have to ask “When will the madness end?” When will parents stand up for what is right for their children? What can we do to better educate people of the plight of public education?

I love teaching social studies to young men and women. I love collaborating with colleagues to make my profession better. I love the challenges that come with working with children. Yet, I can no longer ignore the outside forces that are destroying this endangered profession. It is time for me to stand up and be heard.
